41 comments concerning the proposed changes to the rules.



48 rules with State Records for publication in the *New Mexico Register*. Dr. Washburn  
49 requested a roll call vote. Dr. Wenzel-yes; Dr. Garcia-yes; Ms. Brown-Pirrone-yes; Ms.  
50 Forrest-yes; Dr. Fallen-yes; Dr. Washburn-yes; Dr. Stout-yes. Motion passed.
